NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Installation of an audio visual system comprising:

1. Laser projector suspended from the north side of the west end gallery via a ceiling mount
2. Electric retractable screen with casing mounted by means of a Unistrut support fixed above the wooden wall panelling to the south east corner. The screen casing and Unistrut support system to be painted to match the existing wall colour
3. Associated HDMI inputs, switches, controls and cabling. Cables running from the east to west end to run alongside chancel and pew platform and be covered by carpet. Cables to the electric screen to be behind wood panelling if possible, or else painted to match wall. Cables from input plate at west end to projector to be encased in trunking coloured to match the wooden panelling or wall.
4. Raising of two suspended light fittings in chancel

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
